### Palliative Care Formulary Service - Reminder to Submit Your Quarterly Audit

If you are a pharmacy which provides the Palliative Care Formulary Service and have not yet submitted your quarterly audit return for the latest quarter, (October to December 2023), please remember to do so ASAP. The quarterly audit submission should be completed on the PharmOutcomes platform – see "Palliative Care Service (NHS England) – Quarterly Audit". Thank you.

## **Bradford Supervision - Prescribing Update**

New Vision Bradford has informed us that over the next coming weeks they will be starting to review all patients on Espranor with a view to switch over to generic sublingual buprenorphine tablets. Please see the letter <a href="here">here</a> for details. Pharmacy teams should be aware that a longer supervision time will be needed for sublingual tablets which take longer to dissolve than Espranor (this is reflected in the difference in supervision fees for the 2 products).

#### Hypertension Case-Finding Service - Incentive Fees End 31st March 2024

In addition to payments for providing the service, £15 for each blood pressure check and £45 for each ambulatory blood pressure monitoring (ABPM), incentive payments are also available. These are based on ABPM activity with a one-off payment of £1000 available for pharmacies that meet the yearly target (OR £400 if the pharmacy has previously achieved the £1000 payment by meeting a previous year's target).

This is the last year that incentive payments will be available and to achieve the payment pharmacies need to have delivered 20 ABPMs between 1st April 2023 & 31st March 2024. See under funding and claiming payment here for further details.

#### Reminder – 24-hour ABPMs are no longer required

While 24-hour ABPM provides a fuller picture for prescribers, feedback from pharmacies and GPs is that ABPM during the waking day is better tolerated by patients and may therefore result in more patients accepting the offer. The <u>service specification</u> for the service was therefore updated in June with a change being the removal of the requirement for ABPM to be carried out over 24 hours, to being taken **during the patient's usual waking hours.** 

# Information for Pharmacies across West Yorkshire

## New National Patient Safety Alert for GLP-1RAs for the Treatment of Type 2 Diabetes

A new <u>National Patient Safety Alert</u> (3rd January 2024) has been issued relating to the supply issues being experienced within GLP-1 RA treatments. This supersedes the previous patient safety alert.

The new alert reflects an increase in supply of Rybelsus® tablets (oral semaglutide), which is now sufficient to allow for new initiations of this medicine for people with type 2 diabetes in whom a GLP-1 RA is clinically appropriate (NICE NG28). Please note there are also new actions to be completed, including the review of people currently prescribed Byetta® and Victoza® who, due to product discontinuation and supply issues respectively, should be switched to Rybelsus®.

#### Blood Glucose / Ketone Meters and Lancet Guidance

New West Yorkshire guidance for blood glucose / ketone meters and lancets has been approved and is available at: Medicines information: West Yorkshire Health & Care Partnership (wypartnership.co.uk). The guidance is based on recent commissioning recommendations from NHSE following a national assessment of blood glucose and ketone meters, testing strips and lancets (link). The recommended meters, strips and lancets have passed a rigorous evaluation process ensuring that only the best of the highest quality and, cost-effective devices are approved.

## **Large Text Labels**

Many patients may request a larger text label to support them with taking their medication. Patients that may benefit from this, are those with visual impairments, dementia, and those with learning difficulties and disabilities just to name a few. If a patient is making a request, due to a disability all healthcare professionals must be able to offer reasonable adjustments to support patients.

Most PMR suppliers will have a feature to supply a larger version of a dispensing instructions. However, if your PMR solution doesn't have this feature you can use this website <u>Translabel</u> where you can create them.

## Naloxone Training From Project 6

Naloxone is a drug that can reverse the effects of opioids, such as heroin, methadone, opium, codeine, morphine, and buprenorphine. A naloxone dose can even save someone's life if it's used quickly after they've overdosed on opioids and before emergency help arrives. Medical professionals have been using naloxone in emergencies for many years. Anyone can use Naloxone in an emergency – you don't need to be a doctor or a medical professional; with some quick training, anyone can save the life of someone who has taken an overdose of opiate drugs.
