#### Last Chance to Make Your Claim - The Deadline is 11.59pm Tomorrow!

The Pharmacy Quality Scheme (PQS) 2023/24 declaration period is **open until 11.59pm tomorrow** (Friday 1st March 2024). Pharmacy contractors should make their declaration to the NHSBSA using the MYS Portal application. Contractors must have evidence to demonstrate meeting the quality criteria they have claimed for by the end of 31st March 2024. #### **Pharmacy and GP Resources**

#### **Other Information**

There has been a reported increase in wait times, nationally, for GP appointments (see news story <a href="here">here</a>). With the start of Pharmacy First, this is an ideal opportunity for you to engage and support your GP colleagues. Please work with your surgery to best decide which conditions you would like to focus on and how you will receive / process referrals and patients referred back. \*PLEASE BE AWARE YOU MUST UPDATE YOUR DOS IF YOU ARE UNABLE TO PROVIDE THE SERVICE AT ANY TIME\* – we are trying to avoid situations where GPs lose confidence in the service when it cannot be reliably provided."

## Pharmacy Contraception Service (PCS)

Today (Thursday 29<sup>th</sup> February 2024) is the deadline for opting in to continue providing the PCS if you had previously registered before 1<sup>st</sup> December 2023. If you have not opted in by today and you wish to continue to offer it, you will need to re-register to provide the service via the link on your MYS. This is the same process if you have never offered it and would like to start. Further details can be found here.

### COVID-19 - Spring Booster Campaign

NHS England has written to pharmacy teams to provide further details on the Spring 2024 Covid-19 booster campaign. The letter can be viewed <a href="https://example.com/here">here</a>. There are not expected to be many opportunities for pharmacies not currently providing the service to offer it for spring 2024 – the service is an extension of the 2023-24 winter campaign so will be offered initially only to those pharmacies already signed up. However, where the ICB in West Yorkshire identifies gaps in provision across the county, they may look for Expressions of Interest from pharmacies in those areas. They will contact pharmacies directly so please be aware of any communication should this be of interest to you.

# NATIONAL NO SMOKING DAY

# National No Smoking Day – Wednesday 13th March 2024

13TH MARCH 2024

The National No Smoking Day is fast approaching. Please support the campaign which will run throughout March. If you provide the national

Smoking Cessation Service or the local Stop Smoking Services, this is a great opportunity to promote this campaign to the relevant patients and vice versa. The campaign toolkit will be available in due course on the <u>GOV.uk website</u>.

## Shortage Salbutamol 2.5mg/2.5ml and 5mg/2.5ml Nebuliser Liquid Unit Dose Vials

Salbutamol 2.5mg/2.5ml and 5mg/2.5ml nebuliser liquid is in very limited supply with a resolution date to be confirmed. Alternative beta2-agonists for nebulisation remain available, however, they cannot support an increase in demand. Additional guidance will be issued shortly.

#### Primary and secondary care should:

Prescribers should work with local pharmacy teams to ensure orders are placed within appropriate time frames as lead times may vary. Prescriptions need to be ordered earlier than they usually would to account for the longer lead times. Due to lead times, do not wait for licensed supplies to be exhausted before placing orders for unlicensed imports of salbutamol 2.5mg/2.5ml and 5mg/2.5ml nebuliser liquid (see supporting information below). Refer to Medicines Supply Tool for further information and guidance.

Searches to identify affected patients can be found in the GP clinical systems.

### **Shortage of GLP-1 Receptor Agonists**

The situation with GLP-1s is ongoing and unlikely to improve before the end of 2024. Some GPs have been in touch to say they are getting requests from pharmacies to give the patient a different dose or even brand of GLP-1 depending on the stock levels at the pharmacy. This is not recommended. The latest National Patient Safety Alert <a href="here">here</a> specifically states "do not switch between strengths of a GLP-1 RA solely based on availability".

If a patient is unable to get a supply of their GLP-1 please ask the patient to book themselves in with either GP or their diabetic nurse. The appointment does not need to be urgent, please reassure patients GPs are looking at everyone on GLP-1s. The GP may make changes before they are unable to get stock depending on their glycaemic control/weight loss.

## **Medicines Waste - Patient Survey**

#### Public Health Outreach Opportunity in Bradford and Leeds

Would you be interested in conducting some public health outreach to the Roma community in Bradford & Leeds regarding Nutrition and Hydration, prevention of infection and antibiotic resistance?

The Roma community experience a number of health inequalities related to language, education, access to services etc. West Yorkshire ICB is currently undertaking a piece of work with the VSCE sector and West Yorkshire ICB Antimicrobial Resistance Programme and the Roma community.

During <u>Nutrition and Hydration Awareness week</u> (11<sup>th</sup> – 15<sup>th</sup> March 2024), West Yorkshire ICB is planning to run two independent sessions:

- Connecting Roma, Friday 15<sup>th</sup> March, Farcliffe Centre, 56 Toller Ln, Bradford, BD8 8QH.
- Families First Team & Gypsy Roma Traveller (GRT) & Front Door Early Help Team Wednesday 13<sup>th</sup>
  March 3pm-5pm- Crompton Centre, Leeds

An audience of 15–30 people is expected. The events will focus on providing education and signposting on the importance of Hydration & Nutrition, antimicrobial resistance (a topic of concern within the community and health professionals working with Roma people) but could also include information on where to seek support for healthcare advice specifically infection, such as community pharmacy etc. Members of the Roma community attending will be mostly Czech and Slovak speakers, and so they will be supported by community-based translators at the events. Representation or attendance from a West Yorkshire community pharmacy whose community includes Roma people would be wonderful.
