## Services Information

### Flu Vaccination Service 2024/25 Season

On Tuesday 12th March 2024, the Department of Health and Social Care, the UK Health Security Agency and NHS England jointly published the national Flu Vaccination Programme letter for the 2024/25 season, which can be found <a href="here">here</a>. There are **no changes to the eligible cohorts** for the 2024/25 season and no changes recommended by JCVI for adult flu vaccines for 2024/2025. However, **from 1st September 2024**, pharmacies will only be able to vaccinate pregnant women. Then **from October 2024**, vaccination of the other adult cohorts will commence, with the exact starting date to be confirmed by NHS England in due course.

#### Have You Got an Otoscope?

If you are a Bricks and Mortar pharmacy, then from 1<sup>st</sup> April 2024, an otoscope must be available, and you must be able to offer all clinical pathways. You must also ensure the service is available throughout the pharmacy's full opening hours (i.e. core and supplementary).

### **Hypertension Case Finding Service**

From 11th March 2024, a public campaign will encourage those aged 40 and over, to get a free blood pressure check at the nearest participating pharmacy. Resources have been produced to support the campaign and can be found <a href="here">here</a>. There are both printed and digital resources available for you to use to advertise the service in your pharmacy.

Please be mindful of who and when you target for a BP check – it is not always appropriate to check someone who is actively ill, under stress or flustered, under this service as the reading is likely to be higher than their normal level. It is good practice to repeat the measurement at a later time if the reading seems high and the patient is as detailed above. Please also be aware of the requirement to offer an ABPM where appropriate, in line with the service specification. The specification can be accessed here.

### **New Medicines Service (NMS)**

The NMS has proved invaluable in supporting patients starting new medicines and reducing the risk of non-adherence. It has also proven to be a very useful income stream for contractors.

Over the last few months there have been several high-profile stock shortages in addition to continual stock issues covering a huge range of medications and devices. This has led to a lot of patients having to have their medication reviewed and potentially changed to an alternative that is more readily available.

Please remember that, where the patient will benefit from an intervention, you are able to offer the NMS for a **change in form**. A recent good example of this is the shortage of Fiasp pre-filled pens leading to patients being swapped onto Fiasp cartridges. This is an ideal opportunity to offer the patient NMS, so they understand the differences between the two, ensuring they have been prescribed a reusable pen and feeding back any issues to the GP.

Make sure you are following up every NMS opportunity!

### Social Prescribing Day

Today (14<sup>th</sup> March 2024) is Social Prescribing Day! Social prescribing is a way for local agencies, including pharmacies, to refer people to a link worker. Link workers give people time, focusing on 'what matters to me' and taking a holistic approach to people's health and wellbeing. They connect people to community groups and statutory services for practical and emotional support. Social prescribing works for a wide range of people, including people:

- With one or more long-term conditions.
- Who need support with their mental health.
- Who are lonely or isolated.
- Who have complex social needs which affect their wellbeing.

### Reminder to Verify Your NHS Profile Manager Profile

We want to remind pharmacy owners to update their NHS Profile Manager by 31st March 2024 to ensure your pharmacy's NHS website and Directory of Service (DoS) profile information is current. Learn more about registering and updating your profile

Compliance with the NHS Terms of Service requires verifying opening hours, contact details, facilities, and services each financial quarter. This reminder is issued early to address two key points: ensuring visibility of new services like the Lateral Flow Device (LFD) service and updating opening hours for the upcoming Easter period.

### **Post Payment Verification Requirements**

Within West Yorkshire, we have had a couple of examples of where pharmacies have had to evidence the consultations they have carried out for NMS as part of the PPV requirements. Some contractors have struggled to provide any evidence as they have been through a PMR change.

Please remember a change in PMR should still allow you access to your previous data and this process, and how you should access it, should be discussed at the transition period of PMRs. PMR providers understand the need for your achieved data to be archived securely but in an accessible way should you need it. NHS England will not accept change of PMR supplier as acceptable mitigation as part of a PPV process.

### WY IP Pathfinder ICB Stakeholder Briefing Event

West Yorkshire ICB is participating in the NHS England Independent Prescribing Pathfinder (IP Pathfinder) Programme. The programme has been introduced by NHSE to inform the commissioning framework required to introduce independent prescribing into NHS community pharmacy services. The IP Pathfinder will explore how community pharmacists and their teams can deliver an integrated clinical service aligning prescribing activity with general practice and the population needs of local communities. This national IP Pathfinder Programme provides the opportunity to influence the future of independent prescribing within NHS community pharmacy and to test the different ways that independent prescribing in community pharmacy will benefit patients and the public. Developing the clinical skills of pharmacists as prescribers and pharmacy technicians with enhanced clinical skills to deliver clinical services is a key
