Vaccination Bulletin – 14th April 2024

Recording Batch Number of Moderna Spikevax on PharmOutcomes

When recording the batch number of this vaccine on PharmOutcomes, you only need to enter the **first 7 numbers/letters with no spaces**. If you use the 'Batch Management' section on PharmOutcomes, the details will be stored on the system and populated for you, saving time when recording vaccinations.

New Eye Health Website for West Yorkshire

West Yorkshire Health and Care Partnership has worked with Outlookers, a local support group for people with visual impairments, to develop My Eye Health. This new website has details of over 50 different eye conditions, treatments, self-care guidance and post-surgery advice. It includes information about accessing emergency and non-emergency eye care, local support services and eye care charities. There's also a section dedicated to children's eye health, and a professionals' section for those working in eye care in West Yorkshire. The new site can be accessed <u>here</u>.

Reasonable Adjustments Flag – National Care Records Service (NCRS)

When checking NCRS you may start to see digital Reasonable Adjustments Flags appear on some patient records when accessing the service. This is to highlight to anyone providing care for a patient that they may have learning difficulties, be autistic or require other additional needs or support. The flags are in the process of being added to records as surgeries and other NHS organisations need to have a process in place from April 2024. Currently, most community pharmacy colleagues with NCRS access will only be able to view the flag and its contents, but it is important to be aware of it when providing care to a patient.
