Chair's Report

Welcome to the CPWY Report for 2023/24.

This last year has continued to be a tough trading environment for the whole sector, but our profession continues to be resilient and agile.





As we come to the end of a torrid 5-year CPCF, the sector landscape is significantly different to several years ago. Some pharmacy closures, LloydsPharmacy exiting the sector completely, consolidations and mergers, and an exhausted workforce, what still amazes me, my CPWY officers and committee members is our steadfast commitment to the communities we serve.


We continue to press for fairer core funding for our pharmacy teams and we were delighted to welcome Janet Morrison OBE CEO of Community Pharmacy England (CPE) who spent a day with Nicola and myself and visited local pharmacies to fully understand the pressures we are under.

There has been some positivity over the last 12 months: -

- Introduction of a national Pharmacy First Service and an incredible shout out to all the office team at CPWY who in such a short timescale produced a fantastic training event to launch the new service.
- Within 6 weeks of the announcement and at launch CPWY had over 96% of contractors signed up to provide the service. Thank you to you all for your hard work and effort in getting this service started.
- During the year we also had funding for a Walk-in Consultation Service (WiCS) as we waited for the start of the Pharmacy First Service. Our locality produced over 11,000 consultations in the 5-month period that the service ran. The WiCS helped patients to manage many conditions that would otherwise have had to be dealt with by the GP and 87% of patients seen under this service were managed wholly by the community pharmacy team.
- Across our West Yorkshire pharmacy teams, there has been a 50% uplift in the number of blood pressure (BP) checks undertaken. 110, 559 clinic BP checks have been delivered and over 4000 patients provided with ambulatory blood pressure monitoring where the clinic BP reading was found to be elevated. Potentially, that equates to 4000 patients that may have been identified as having previously undiagnosed hypertension, (one of the top five risk factors for all premature death and disability in England), and early identification will help improve outcomes for these patients.

CEO's Report

Community Pharmacy West Yorkshire (CPWY) is clear on our purpose; to support and represent our pharmacy contractors across West Yorkshire. Our ambition is that community pharmacy is at the heart of the communities they serve; an integrated part of a sustainable NHS and care system, promoting and improving health and wellbeing for patients and the public, now and in the future. It is our role at CPWY to work with pharmacy teams, along with local and national stakeholders, to realise this vision for community pharmacy in West Yorkshire.



The current financial situation for community pharmacy has, quite rightly, led us to an increased focus on the support we offer contractors and their pharmacy teams to help them to continue delivering quality services to their patients whilst maximising income to maintain a viable business. This drives our activity and work which is guided by our strategy. A shift in focus to support more the delivery of the National Advanced Services, National Enhanced Services and Essential Services to support contractors make the most of the opportunity to access the funding which is already on the table for us. Although we are focused more on the delivery of national services, we continue to work with local commissioners to negotiate and agree local services to maximise funding opportunity for our contractors and help meet the needs of our local populations. In the last 12 months, provision of these services by contractors have generated a minimum of £1,008,533 (estimated) in additional revenue. We have endeavoured to make the LPC as available as possible to our contractors by adding 'book a visit' options to many emails and communications.

2023-2024 was another extremely difficult year for pharmacy contractors. The operating environment with ongoing uncertainty around funding, rising costs, and very real pressures from providing front line services due to the workforce shortages, all made for incredibly challenging conditions. During these uncertain times pharmacy teams have continued to put their patients first and deliver exceptional care. Thank you for your continued effort and support during these challenging times.

Thank you to my CPWY team for the effort and commitment you have shown this year as we have made great strides and progress with our deliverables. Kathryn, Lauren, Lisa, Sukhi and Phil all deserve a massive thank you. Additionally thank you to our outgoing committee members and our new ones for the support and commitment you show to guide our LPC along the right path.

ICB and Local Stakeholder Relations:

We have continued to strengthen our relationships with local commissioners and other key stakeholders, providing them with an increasing awareness of how community pharmacy can support across the wider healthcare system. This has led the CPWY team to be invited to attend an increasing number of meetings across West Yorkshire at all organisational levels to ensure that we represent community pharmacy in the key places. This includes regular meetings with NHS England, maintaining links with ICBs, local authorities, hospital trusts and local medical committees, and representation at numerous meetings including Digital Development, Primary Care, Medicines Safety and Prescribing Committees. We attend meetings to ensure that the voice of community pharmacy is included and promoted in local discussions, to keep abreast on what is happening in our area and to feedback relevant information to contractors. CPWY ensures that we have a seat at the table when it comes to all the working groups to integrate community pharmacy into the wider NHS. We attend and represent you at the Primary Care Access and Delivery Group, Community Pharmacy Integration Group, Smoking Cessation Service working group, DMS working group, and many more to maximise service delivery and support the integration of services.

Simplified and Effective Communication:

This year a huge piece of work has been the rebranding of CPWY to the new colours in line with the recommendations by CPE to provide a more aligned branding with local to the national pharmacy voice. We hope this refreshed and modern look makes our website and content more appealing and easier to digest.

We have done lots of work to slim down our content to the key pieces of information we feel are most relevant to you as we know your time is precious. We are working to incorporate different communications styles with images and videos to help you take in the content you need to know in a quicker and more enjoyable way.

Launch of Pharmacy First:

The highlight of the year was our first face-to-face event since COVID-19 where we broke CPWY records with the number of attendees who attended. We focused on supporting our contactors to get ready to deliver Pharmacy First and we had various experts and stakeholders who supported us with the event. We received some great feedback from the event, and it was so lovely to be able to network and see colleagues doing the same after such a long period of time.

We also organised and supported almost 240 colleagues to be trained in ENT via CPPE over 4 events across West Yorkshire.

Our communications from the announcement in November 2023 were heavily focused on supporting contractors be ready to deliver Pharmacy First brilliantly.

- Over 96% of you registered to deliver the service and since the launch in January, West Yorkshire has carried out 35,324 Pharmacy First consultations. This total is made up of 12,651 clinical pathway consultations, 16,196 minor illness consultations and 6477 urgent medicines supplies.
- Prior to the launch of Pharmacy First, all West Yorkshire GP practices received a briefing about the
 service from CPWY by presentations given at place level meetings for clinical directors, practice
 managers and/or business managers. In addition, in the year to 31st March 2024, 120 GP practices
 received some level of individual support in the form of attendance at a practice meeting and/or
 training support provided by Amanda or Neelam, or in some cases by the PCN Community Pharmacy
 Lead. Support to GP practices continues in the current year, focusing on practices with low or no
 recorded GP referrals to community pharmacies.

The ICB has supported with funding to support the integration of this service alongside the Hypertension Case-Finding Service and the Pharmacy Contraception Service. Neelam and Amanda have done a great job.

Public Health:

We meet on a quarterly basis with commissioning colleagues from West Yorkshire and the council representatives from the 5 Places Public Health teams, to discuss community pharmacy issues relating to locally commissioned public health services. We have planned strategic actions in order to support service delivery, reduce the burden on delivery of the service specifications and negotiate for increased renumeration of pharmacy commissioned services. Since the 1st of April 2013, every Health and Wellbeing Board (HWB) in England has had a statutory responsibility to publish and keep up to date a statement of the needs for pharmaceutical services of the population in its area. This is referred to as a Pharmaceutical Needs Assessment (PNA). The current regulations involve a market entry test based on pharmaceutical needs assessments, so this is an important area of the LPC's work. During the year we have been involved in the steering groups for the West Yorkshire Pharmaceutical Needs Assessments and will continue to do so as the new PNA are being written in the coming year.

This included ensuring that the PNA represents the required needs of the geography and supporting pharmacy contractors to respond to the pharmacy survey.

Treasurer's Report

In these difficult times I would like to assure you as Treasurer that every year we look at every line of the accounts to see where savings can be made to keep the levy as low as possible. We also use any surplus to offset levy increases.

April 2023 saw a significant increase in our levy payment to CPE as a result of a change in how the levy is calculated. This meant that for the first time in many years we needed to increase the levy paid by West Yorkshire contractors. We were able to off-set some of the increase by subsidising the levy with £30k from project management funding received from commissioners and setting a budget to reduce our reserves to 4 months.

Please be assured that our financial governance meets the CPE expectation, and in a lot of areas exceeds this, to give you the assurance that LPC funds are being looked after properly.
