Uplift to Advanced Payments for April and May 2025

In discussions with DHSC, CPE has agreed a mechanism to allow pharmacy owners to receive the 19p Single Activity Fee (SAF) increase sooner for dispensing months of April 2025 and May 2025. The advanced payments for these dispensing months will be adjusted to incorporate the uplift to the SAF. No adjustment to advance payments will be required from June 2025 dispensing month onwards.
