Services Information

Sign-up Process Launched for Provision of COVID-19 Vaccinations from October 2025 (Deadline for Submissions is 16th June 2025)

NHSE has opened the procurement process for pharmacies that wish to provide the COVID-19 Vaccination Service from their premises from 1st October 2025. This only applies to:

- Pharmacies not already contracted to provide the service and wishing to apply to provide it from 1st October 2025; and
- Pharmacies already contracted to provide the service but whose contract only runs up until the end of August 2025.

Most pharmacies already providing the service are contracted until 31st March 2026; those pharmacies **do not need** to re-apply in order to continue to provide the service from October 2025, as their contract already covers provision until 31st March 2026. Information for Pharmacies across West Yorkshire

Important Regulatory Changes Affecting Distance Selling Premises (DSP) Pharmacies and Core Opening Hours

From 23rd June 2025, the DSP market entry exemption will close and a more flexible application process will be introduced for changing a pharmacy's core opening hours. A further change to prevent DSP pharmacies from delivering Directed services face-to-face with patients onsite will also come into effect later this year. Terms of Service Requirement: Data Security & Protection Toolkit 2025

The Data Security and Protection Toolkit must be completed by the end of June 2025. All the questions marked mandatory in the toolkit must be completed as part of a pharmacy's NHS Terms of Service to meet the minimum information governance (IG) requirements. GPhC Inspector Update

Following our regular update with the GPhC, we have been asked to share some reminders with our community pharmacy colleagues.

- 1. It is illegal to advertise specific prescription only medicines (POMs) by name, or offer special price deals. This includes marketing in windows, websites, online and via social media. All is now being used by the Advertising Standards Authority (ASA) to scan for this activity and the fines can be substantial. More info on this here.
- 2. GPhC has received concerns about pharmacies supplying non-medicinal, unregulated, unlicensed products, including a substance called 'Lemon Bottle' which has been advertised on social media, and claims to dissolve fat. Additionally, there has been an increase in pharmacies providing complementary or alternative therapy services, such as acupuncture and cupping, to patients and the public. Please update yourself with this information to make sure you maintain your professional practice and work with the regulations of the profession. More info on this here.

Choose New Facilities in the NHS Profile Manager

NHS Profile Manager now has an improved set of facilities. The new list allows you to select your facilities from a wider set of options, to help patients find more accurate information. Sign into the NHS Profile Manager, go to facilities and select your new options from the improved list. Upcoming Change to NHS Ratings & Reviews on NHS.uk

The NHS Ratings & Reviews service on NHS.uk will be hidden from public view from **20th June 2025**. This decision follows a comprehensive review of the service's usage, technical sustainability, and alignment with strategic priorities.

What This Means for You

- Patients will no longer be able to view or leave reviews for your service on NHS.uk.
- You will no longer need to respond to or manage reviews via the Comment Responder Tool.
- Your service profile will remain active, but the ratings and reviews section will be hidden.
