Services Information

Reminder: Important Pharmacy First Service Changes Which Have Come into Effect This Month

CPE's recent news story summarises the changes that take effect for the Pharmacy First service from 1st June 2025. We have provided a very brief summary below but please take time to read the full article [here](#).

- **A new intermediary band for the fixed monthly payment** has now been introduced: £500 for those delivering 20–29 clinical pathway consultations and £1000 for those that achieve 30 or more.
- **Changes to the claim period which has now been reduced to one month.** Pharmacy First consultations provided from 1st June 2025 will now need to be claimed within one month from the end of the month in which they were provided. For example, consultations provided in June will need to be claimed on MYS by the last day of July. **This also means that if you have not yet claimed for consultations carried out in March, April & May 2025, you must claim for these before midnight on 30th June 2025 to receive payment.**
- **Monthly update to clinical pathway caps.** New clinical pathway band assignments and monthly caps came into force. See [here](#).

- **LFD Service** – the deadline to ensure that recent changes made to eligible patient cohorts for this service have been implemented is the 16 June 2025. See the CPE news story [here](#).
- **COVID-19** – the interim response deadline for submitting applications to provide COVID vaccinations for the 2025/26 Autumn/Winter campaign is 16th June 2025. See [here](#).

Final Reminder: Funding Opportunity for Community Pharmacy Technician Apprenticeship Programme

The community pharmacy technician apprenticeship programme has launched for 2025, supporting Pre-registration Trainee Pharmacy Technicians (PTPTs) to complete a 24-month apprenticeship in community pharmacy.

Successful applicants will receive a training contribution of £15,053 per trainee, per year for two years.
