Community Pharmacy England wants to know what pharmacy owners in West Yorkshire would like to see in the 2026/27 Community Pharmacy Contractual Framework (CPCF). An opinion poll asking how you think funding should be allocated, what regulatory changes might help your pharmacy, and which services to consider introducing, is available. Findings from the survey will inform national negotiating priorities and contribute to efforts to push for further improvements and support for the sector.

Recording GP Referrals on PharmOutcomes

Pharmacy First on PharmOutcomes – Signposted or Referral?

Getting it right could save you money!

When processing GP referrals for Pharmacy First Clinical Pathway conditions on PharmOutcomes, pharmacies are asked to indicate how the patient has entered the service. If a GP referral has been received, into PharmOutcomes or via NHSmail, pharmacists should ensure they tick the correct option on screen i.e. 'Referral' when they move onto the clinical pathway template.

Method of entry
Signposted Self-referral Referral

This ensures that the consultation is correctly coded as a Referral and ensures the surgery referral figures demonstrate that surgeries are actively referring into the service. Referred consultations incorrectly coded as 'signposted' or 'self-referral' will incur a charge to the pharmacy for processing the consultation under their provider pays agreement with PharmOutcomes.

NHS Flu Vaccination Service

Permission for Off-Site Vaccination - A key change for this season includes a requirement to seek permission from the commissioner prior to undertaking vaccinations at a location off the pharmacy premises. We are currently trying to establish the local process for applying for permission and further updates will be shared in due course.

Vaccines - As it's just a couple of weeks away before the flu campaign starts, (1st September for pregnant women), just a reminder of the reinforced advice issued by NHSE regarding the restriction on the use of second line vaccines. The <u>annual flu letter for 2025/26</u> made it clear that first line vaccines for a given cohort should be ordered ahead of the flu season and clinics should be planned using the recommended first line vaccine. Once the vaccination campaign has started, if providers need additional stock, second line vaccines should only be ordered if first line options are not available to order. Where a provider does not have a first line vaccine in stock, patients should be directed to an alternative provider who has stock of a first line vaccine or told to rebook when the new stock is available. Vaccination with a second line vaccine should only be considered on an exceptional basis where there is a valid reason why the patient may not return for a further appointment.

NBS is Now Open to Post Appointments (Flu & COVID) - The National Booking Service (NBS) is now open for pharmacies to post appointments for adult flu and COVID vaccinations - see here.

The use of NBS for flu vaccinations is a voluntary option and the functionality within NHS Profile Manager, which was added last year to allow pharmacies to add a link to their own flu vaccination booking system within their NHS website profile, remains in place.

Any pharmacies that have not yet registered for NBS but would like to take up the offer to use NBS (and who don't already have access to NBS as part of the COVID-19 Vaccination Service), can still apply by completing the <u>NBS registration flu form</u>. Login details are usually received within 10 working days.

Access to a PoC System – Have you Chosen Your IT System? – All vaccination sites must use one of the assured Point of Care (PoC) systems to record Flu and COVID-19 vaccinations. In previous seasons the PoC system has been provided by NHSE but for 2025/26 pharmacy owners must choose which PoC system they want to use, ahead of the autumn/winter campaign.
